## **Bayland Park Little League Terms and Conditions**

- 1. I/We, the parents/guardians of the above-named candidate for a position on a Little League team, hereby give my/our approval to participate in any and all Little League activities, including transportation to and from the activities.
- 2. I/We know that participation in baseball or softball may result in serious injuries and protective equipment does not prevent all injuries to players, and do hereby waive, release, absolve, indemnify, and agree to hold harmless Bayland Park Little League, Little League Baseball/Softball, Incorporated, the organizers, sponsors, supervisors, participants, and persons transporting my/our child to and from activities from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.
- 3. If applicable, I/We agree to return upon request any equipment issued to my/our child in as good conditions as when received except for normal wear and tear.
- 4. I/We agree to provide proof of legal residence (as defined by Little League Baseball, Incorporated) and age.
- 5. I/We understand that our child (candidate) must be eligible under the residence/school attendance and age regulations of Little League Baseball/Softball, Incorporated, to participate in this Local League, and that if any controversy arises regarding residence/school attendance and/or age, the decision of the Little League Charter Committee in Williamsport shall be final and binding. I/We further understand that if any participant on a Little League team does not qualify for participation in the league based on residence (as defined by Little League Baseball, Incorporated) and/or age, such participant and/or team on which he/she participates be found ineligible, and forfeit(s) and/or suspension of Tournament privileges may be decreed by action of the Little League Charter Committee or Tournament
- 6. I/We agree that our child (candidate) may be required to try out for a team. If such does not attend at least 50% of the try outs, Bayland Park Little League Board of Directors' approval is required for such candidate to be placed on a team.
- 7. If applicable, I/We understand that my/our child (candidate) may be chosen at any time to play on a Major Division team, if he/she is of the correct age for such division as determined by Bayland Park Little League, and Little League Baseball/Softball. Declining to move up to such Major Division team will result in the forfeiture of eligibility for the Major Division for the current season, and subject to further restrictions by Bayland Park Little League.
- 8. I/We will furnish a certified birth certificate of the above-named candidate to League Officials.
- 9. I/We understand that my information as the parent or guardian of such above-named candidate is sent by Bayland Park Little League to Little League International each year. You may opt-out of communication from Little League International at any time.
- 10. In the event of an emergency, if Parental Authorization cannot be obtained and the Player's Physician cannot be reached. I/We hereby authorize the named player to be treated by an available physician or other trained medical staff.
- 11. Participants in Bayland Park Little League's programs acknowledge that photographs or videos may be taken during activities within our practices, games and other Bayland Park Little League programs/events. By participating in our programs, you allow that reproductions of these photographic materials may be used in promotional activities including, but not limited to: brochures, our website, email campaigns, social media, and more exclusively by the Bayland Park Little League.

## Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, (or COVID-19), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Bayland Park Little League (BPLL) is complying with guidance and taking reasonable measures to reduce the spread of COVID-19. However, the risk cannot be completely eliminated and BPLL cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, participating in/or attending, BPLL activities could increase your risk and your child(ren)'s risk of contracting COVID-19. Consequently, for the safety of our volunteers, players, parents, and other visitors, BPLL requires all persons participating in its activities during this pandemic to acknowledge an assumption of the risk, waive (i.e. release) liability and agree to abide by our COVID-19 protocols, as follows:

- 1. I request to participate in BPLL related activities. I am the parent and/or the legal guardian of the below-named child(ren) participant(s), and I request that he/she/they be allowed to participate in all BPLL related activities, and I give my permission for he/she/they to do so.
- 2. Assumption of Risk. By signing this agreement, I understand and acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending BPLL activities, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand that the risk of becoming exposed to or infected by COVID-19 by participating in BPLL activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, BPLL, it's agents, representatives, volunteers, and other program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any harm, loss, or injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance or participation in BPLL activities ("Claims").
- 3. Waiver of Liability. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless BPLL, its agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of BPLL, its agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any BPLL activity.
- 4. Agreement to Abide by COVID-19 Protocols. I agree that my child(ren) and/or my family or our guests, will not enter any grounds or facilities if I am, and/or he/she/they is/are, feeling ill, which includes, but is not limited to, the following symptoms: fever, cough, difficulty breathing, shortness of breath, chest pain, and/or bluish lips or face. I understand and acknowledge that my child(ren) and/or my family and our guests, may be denied entrance or admittance if BPLL determines that I am, or he/she/they is/are, showing any such symptoms. I warrant and represent that I am not aware of any medical condition of myself and/or, my child(ren) which would render it inappropriate for me and/or him/her/they to participate in the activity. I agree to abide by all COVID-19 guidelines and other COVID-19 related policies and procedures, which may change over time as circumstances change over time. This may include hand washing requirements and temperature checks for my child(ren) and/or my family and our guests. I agree to practice good hygiene etiquette such as sneezing into my elbow, utilizing tissues, and avoid touching my eyes, nose, and mouth, and, if applicable, to instruct my child(ren) to do the same. I understand and acknowledge that my failure to abide by and/or my failure to ensure that any child of mine abides by this agreement may result in my child/(ren) and/or, my family, being removed from the BPLL activity.
